2.3 Free from corruption in work operations Has a good faith intention to promote work practices based on moral and ethical principles so that the unit is free from corruption in terms of policy and malfeasance. without using the position In any favor or accepting bribes

2.4. Moral culture in the organization Create a culture of honesty in the organization and maintain a culture of integrity with the organization. Anti-corruption and anti-conflict operations are carried out.

2.5 Moral aspects of working in the agency It will instill values and attitudes for personnel to focus on the public interest, have knowledge, understanding, adhere to moral principles and ethics, apply the Sufficiency Economy Philosophy in management and life. Fairness in work and morality in the administration of all 4 work groups

2.6 Intra-agency communication will promote and develop communication channels by applying modern technology to public relations for parents and communities in the service area of Ban Jod Srivichai School Access to relevant information by revealing, promptly, accurately, and public relations for the public to report information, clues, corruption, complaints. Complaint through the Complaint Center
